The primary goal of this note is to invite you to York Branch's Annual Members Meeting on Tuesday April 21 2020 at the Richvale Community Centre in Richmond Hill. Please save the date and plan to attend. This is an important business meeting with the presentation of the 2019 finances and the 2020 and 2021 budgets. There are also elections of the Branch Directors and a separate election for the Branch President. We have a good slate of Directors but welcome those interested to join us. Our Branch membership has previously defined some reserve funds and the Board would like to discuss and ask for your approval in broadening the definition of two of them. First is the Defence of Benefits fund which is to support initiatives to promote or protect significant pension or health benefits. We propose to broaden the definition to also include advocating for issues of importance to Federal Retirees.

The second proposal is to broaden the definition and rename the Facility Reserve Fund to the Operating Reserve Fund We have been very fortunate to have access at no cost to the Community Room at the York Regional Police building for Board meetings. From time to time, the police require the room and we need to meet elsewhere. The reserve fund is used when required and it is topped up as required with any year end surplus funds. Additionally, when a new President is elected, we would like them to accompany the outgoing President to the National Meeting in Ottawa as an observer. As a new President takes office every few years, we propose using this reserve fund for this expense rather than trying to show an expense in the annual budget. Your input is important.
