Total cost for the Spring Annual Meeting on 18 April was \$640.00, \$60.00 under budget. This includes \$170.00 for Hall Rental, \$50.00 for Bartender Fees (\$50 was deducted from the original cost due to the late arrival of the bartender), \$400 for sandwiches & \$15 in tips for the kitchen staff.

5 door prizes of \$20 each were won by Colin Wright, Bill Goodman, Flo Rowe, May LeBlanc & John Martin. The \$100 for door prizes was taken from BBQ Ticket sales.

\$500.00 from BBQ Ticket sales was deposited in the BMO account.

Our 1st quarter 2023 DDS payment of \$2,201.47 was received on 20 Apr 23. The next payment (2nd quarter) of approx \$2,200 is due on 21 Jul 23.

The KCU called to confirm that our GIC will renew at 4.5% next week.
